

Dr. Edmunds' book contradicts itself, is inconsistent, and the layout is ridiculous... it seems as if I'm reading a novel instead of a textbook. Study test questions should be included or at least a study guide one could buy separately. The only thing bolded throughout this book are the headings. This is sooo HARD READ... In grad school, one needs a book that can easily be skimmed over and over again... I waste so much time trying to pick out important information and I get annoyed with reading her opinions instead of facts. Additionally, the same concepts are constantly repeated throughout different chapters. This should not be a required textbook for anyone and I do not suggest buying this for supplemental textbook for another pharm class. It is unacceptable to consider this a textbook. I hope this review saved others the disappointment of purchasing for supplemental use. And for those of you who are required to buy this for pharm, my deepest sympathy.
